PETITION FOR CONTEMPT AND ORDER TO SHOW CAUSE

COMES NOW, The Florida Bar, by and through its undersigned attorney, pursuant to Rule 3-7.7(g) and petitions the Supreme Court of Florida to enter an order to show cause why Respondent herein should not be held in contempt of this court's orders entered in Supreme Court Case Numbers SC15-1085 and SC17-1826 and why Respondent should not be immediately disbarred. In support of its Petition, The Florida Bar would show as follows:

- 1. By Supreme Court Order, entered in Case Number SC15-1085, dated September 14, 2016, this Court suspended Respondent from the practice of law for three years, effective thirty days from the date of the order. The effective date of Respondent's suspension was October 14, 2016.
- 2. By Supreme Court Order, entered in Case Number SC17-1826, dated October 26, 2017, this Court suspended Respondent from the practice of law for

three years, *nunc pro tunc* to October 14, 2016. The effective date of Respondent's suspension was October 14, 2016. At the time of this Court's order, Respondent still was serving his suspension ordered in Case Number SC15-1085.

- 3. Respondent has not petitioned for reinstatement from his suspension in Case Numbers SC15-1085 and SC17-1826.
- 4. During all times material, Respondent was not employed in any capacity by an attorney licensed to practice law in Florida.
- 5. In or around August 2018, Horace Knight, a resident of Maryland, contacted Respondent seeking his assistance in preparing the necessary documents to probate his mother's estate through summary administration. The Affidavit of Horace Knight is attached hereto and incorporated herein as Exhibit A.
- 6. While suspended from the practice of law, Respondent agreed to prepare the necessary documents for Mr. Knight to execute and file with the probate court to convert his mother's probate matter to a summary administration case. The transcript of Respondent's sworn statement is attached hereto and incorporated herein as Exhibit B.
- 7. Respondent did not advise Mr. Knight that he was suspended from the practice of law. Respondent advised Mr. Knight that he was not practicing law at that time but agreed to review documents Mr. Knight asked to send him.

- 8. By email dated August 24, 2018, Mr. Knight sent Respondent copies of documents he previously filed with the court *pro se* and the court's order dated August 15, 2018 denying Mr. Knight's petition for disposition of property without administration and granting him twenty days to convert the matter to a summary administration case. A copy of said email is attached hereto and incorporated herein as Exhibit C.
- 9. Respondent prepared the Petition for Summary Administration,
 Notice to Creditors and Formal Notice to the Agency for Health. The Notice to
 Creditors contained the case number for another, unrelated probate. None of the
 documents indicated they had been prepared by a nonlawyer. See Exhibit B, the
 transcript of Respondent's sworn statement at Exhibit 8.
- 10. Respondent did not prepare any of the documents under the supervision of an attorney licensed to practice law in Florida.
- 11. Respondent sent the documents to Mr. Knight and advised him to him to sign and date the Petition For Summary Administration and send it by certified mail to the court. He also advised Mr. Knight to sign and date the Formal Notice to the Agency for Health located in Tallahassee, Florida and send it by certified mail. Respondent also advised Mr. Knight to contact the Clerk for the Circuit Court after twenty days to check on the status of the Petition For Summary Administration. See Exhibit A, the Affidavit of Horace Knight.

- 12. Mr. Knight filed the documents prepared by Respondent with the court on September 5, 2018. Respondent did not advise Mr. Knight to seek the advice of an attorney licensed in the State of Florida prior to filing the documents with the probate court.
- 13. Respondent's conduct constitutes the unauthorized practice of law and violates this Court's orders in SC15-1085 and SC17-1826.
- 14. The other members of The Florida Bar should not have to pay for Respondent's noncompliance with this Court's order and the instant proceeding. Therefore, the Bar is requesting administrative costs of \$1,250.00 against Respondent.

WHEREFORE, Petitioner respectfully requests this Court enter an order compelling John Daneil Ellis, Jr. to show cause why he should not be held in contempt of this Court's Orders and disbarred immediately.

AFFIDAVIT

- I, Horace Knight, after being duly sworn, say:
- 1. My mother, Lucille Smith, passed away in Orange County, Florida on March 13, 2018.
- 2. At the time of her death, my mother had only one checking account with a balance of approximately \$1,178.42 and two small life insurance policies totaling less than \$1,000.00.
 - 3. I am not an attorney and have no legal training.
- 4. Prior to her death, my mother lost her home due to a real estate loan scam. I still was in contact with the attorney who represented Bank of America, Tracy Adams, in connection with the foreclosure. Ms. Adams sent me a blank form for a Verified Statement for Disposition of Personal Property Without Administration that I could file with the court and finalize my mother's small estate.
- 5. I completed the form and filed it with the Orange County, Florida Clerk of Court on or about May 29, 2018.

- 6. On August 16, 2018, the probate court entered an order basically telling me that my mother's estate did not qualify for disposition of personal property without administration and that I needed to seek summary administration.

 The Court's order provided me with 20 days to accomplish this new filing.
- 7. Because did not know any attorneys in Florida who could handle such a small matter, I contacted my former fraternity brother, Keith Miles, who was the Deputy Athletic Director at FAMU. Mr. Miles suggested that I contact John Ellis for help.
- 8. I assumed that Mr. Ellis was an attorney, but when I contacted him, there was never any discussion about his status as an attorney.
- 9. Mr. Ellis told me that I needed to file a Petition for Summary
 Administration and that he could draw up all the documents I needed for filing
 with the probate court. I provided Mr. Ellis with the information that I originally
 listed in the Personal Property Without Administration.
- 10. Mr. Ellis prepared the Notice to Creditors and the Petition for Summary Administration and sent them to me for my signature.
- 11. I signed the documents and filed them with the probate court as Mr. Ellis directed.

- 12. Mr. Ellis did not provide me with any document to file with the court indicting that these documents had been prepared by a non-lawyer or that I had been assisted by a non-lawyer in preparing and filing these documents.
- Administration and send it by certified mail to Judge Janet C. Thorpe. He also told me that I should sign and date the Formal Notice to the Agency for Health located in Tallahassee, Florida and send it by certified mail. Mr. Ellis also told me to contact the Clerk for the Circuit Court after 20 days for the status of the Petition for Summary Administration of my mother's estate.
- 14. I signed the documents Mr. Ellis sent me on August 28, 2018 and filed them with the court on September 5, 2018.
- 15. I last spoke to Mr. Ellis about my mother's estate around September 18, 2018.
- 16. Mr. Ellis did not charge me for his services and I did not pay Mr. Ellis any money for his work.
- 17. Mr. Ellis did not tell me that he was suspended from the practice of law and was not allowed to provide me with legal services or legal advice.

- 11 are you -- were you employed?
- 12 A No, ma'am.
- Okay. And how are you supporting yourself?

- 15 Q And what is it now? You said "was."

- 10 A I don't check it ---
- 11 Q --- regularly?
- 12 A --- maybe once a week.
- 13 Q Okay. Just in case -- if I need to send you
- 14 something.
- Where are you residing?
- 16 A 1021 Martex Drive, Apopka, Florida.
- 17 Q Can you spell that. Martex.
- 18 A M-a-r-t-e-x Drive, Apopka, Florida 32703.
- 19 Q Now, we previously mentioned these two orders of
- 20 suspension. What other discipline history have you had?
- 21 A Since these?
- 22 Q Prior to this. If you remember.
- 23 A No, ma'am, I don't remember.
- 24 Q Okay.
- Okay. Can you explain to me who Horace Knight

- 1 is.
- 2 A Horace Knight is a fraternity brother of mine.
- 3 Q And what fraternity was that?
- 4 A Alpha Phi Alpha fraternity.
- 5 Q And what school?
- 6 A Florida A&M University.
- 7 Q Okay. And were you fraternity brothers with him
- 8 your entire career in college, or did you ---
- 9 A No, ma'am. He's much -- he's -- I'm -- I have
- 10 never met him.
- 11 Q Oh. You haven't.
- 12 A But he's much older than me.
- Okay. So you weren't in school with him.
- 14 A No, ma'am.

- 15 Q Showing you what's marked Exhibit 7.
- 16 A Okay.
- 17 Q And that's dated August 16th, 2018. Is that
- 18 correct?
- 19 A Yes, ma'am.
- 20 Q Okay. And what was the reason the court denied
- 21 his petition for disposition of property without
- 22 administration?
- 23 A Say the petition does not qualify for the
- 24 Disposition of Property without Administration.*
- Q Um-hmm.

- 1 A And it says he has 20 days to convert this action
- 2 to a summary administration.
- 3 Q Okay. So what does that mean he needs to do?
- 4 A He needs to file a summary administration
- 5 petition.
- 6 Q Okay. And is there a reason of what would make
- 7 what his needs were qualify -- require a summary
- 8 administration?
- 9 A I don't know, ma'am.
- 10 Q You don't know.
- 11 A No, ma'am.
- 12 Q Do you know the difference between why you would
- 13 need one, and one, you wouldn't?
- 14 A Yes, ma'am.
- 15 Q Okay.
- 16 A But that wasn't -- all I was getting was this
- 17 sheet of paper here.
- 18 Q Okay.
- 19 A So I don't know. I don't -- I don't have the
- 20 insight.
- 21 Q Okay. So you did see this document.
